State	Project Sponsor	Project Description
AK	Emmonak Village	The Emmonak Village will receive funding to develop a transit plan. The plan will improve access to transit services in Emmonak and better connect residents to jobs and economic opportunities.
AK	Native Village of Tununak	The Native Village of Tununak will receive funding to develop a transit plan, buy a vehicle and operate a transit system. The plan will improve access to transit services for this remote Alaska Native village on Nelsor Road, 115 miles northwest of Anchorage, and better connect residents to jobs, healthcare and economic opportunities.
AK	Nunakauyarmiut Tribe	The Nunakauyarmiut Tribe will receive funding to develop and operate a transit program and buy a new vehicle. This will allow the tribe, located in Bethel, Alaska, 115 miles northwest of Bethel, to better serve residents.
AK	Igiugig Village	The Igiugig Village, with a population of 71, will receive funding to initiate a tribal transit program and buy a new, accessible vehicle. This will allow the tribe to better serve residents in the village, located in Seward, Alaska on the mouth of the Kvichak River and the Kvichak National Preserve.
AK	Metlakatla Indian Community	The Metlakatla Indian Community will receive funding to initiate a new fixed-route service between the Metlakatla Municipal Building and the Annaham Ferry Terminal. The new service will improve the reliability and mobility for tribal members and visitors to the Metlakatla Indian Community and the Metlakatla Islands Reserve in Alaska.

AK	Native Village of Unalakleet	The Native Village of Unalakleet will receive funding to build a bus garage and maintenance facility, improve the state of repair of its fleet by providing sheltered indoor space to store and repair vehicles, and the village, located on the Norton Sound 180 miles north of Nome, provides on-demand transit to help residents get to the health clinic, grocery store, post office, airport, and other services.
AZ	Hualapai Indian Tribe	The Hualapai Indian Tribe will receive funding to purchase approximately two replacement buses that will replace vehicles that have exceeded their useful life and will serve a rural area in northwestern Arizona on the Hualapai reservation and neighboring communities, allowing residents to access jobs, schools, and other essential services.
CA	Yurok Tribe	The Yurok Tribe will receive funding to buy replacement software, build bus shelters and ferry dock, and expand transit routes. The improved ferry service, provide shelter for new low-income residents, buses, and improve service so residents can access schools, healthcare and essential services.
ID	Coeur D' Alene Tribe	The Coeur D' Alene Tribe will receive funding to purchase buses for their transit system, which serves approximately 65,750 riders annually in Benewah, and Kootenai counties in northern Idaho. The buses will allow the tribe to continue to provide safe, timely, and fare-free transportation that allows residents to access schools, healthcare and essential services.
ID	Nez Perce Tribe	The Nez Perce Tribe's Appaloosa Express Transit Authority operates transit service on and near the Nez Perce Reservation in North Central Idaho, will receive funding to ensure continued transit services for its tribal members. The funding will help the Tribe improve access to jobs, healthcare and essential services in and around the reservation.
MI	Bay Mills Indian Community	The Bay Mills Indian Community will receive funding to ensure continued transit services for its tribal members located in a rural area in Chippewa County, Michigan. The funding will help the Tribe improve access to jobs, healthcare and essential services for its community.
NE	Winnebago Tribe of Nebraska	The Winnebago Tribe of Nebraska will receive funding to buy replacement vehicles and maintenance equipment and to upgrade its maintenance facility. The

		improve the fleet's state of repair, especially during winter weather conditions.
NM	Pueblo of Santa Clara	The Pueblo of Santa Clara will receive funding for two bus stops with shelters and passenger seating to improve accessibility. The improvements will help the Pueblo of Santa Clara continue to provide safe and reliable transit service to help tribal residents access jobs, education, and healthcare.
NM	Pueblo of Tesuque	The Pueblo of Tesuque will receive funding for bus stops with shelters and passenger seating to improve accessibility. The improvements will help the Pueblo of Tesuque address its fleet of good repair needs and help the Pueblo of Tesuque provide safe and reliable transit service to help tribal residents access jobs, education and healthcare.
NM	Jicarilla Apache Nation	The Jicarilla Apache Nation will receive funding for new buses that will replace buses that have exceeded their useful life. The project will support residents in central New Mexico with greater access to jobs, education, healthcare and economic opportunities.
NV	Walker River Paiute Tribe	The Walker River Paiute Tribe will receive funding to initiate transit service. The Tribe will hire staff, purchase tires, software, and equipment. The Agai-Dagui Transit Program will provide Tribal residents with access to jobs, schools, healthcare, and other essential services.
NY	Saint Regis Mohawk Tribe	The Saint Regis Mohawk Tribe will receive funding for a replacement vehicle and a new vehicle, and for a transit center. This project will improve access for its tribal community, located in upstate New York near the Canadian border, and better connect them to jobs, education, healthcare and economic opportunities.
OK	Eastern Shawnee Tribe of Oklahoma on behalf of Northeast Oklahoma Tribal Transit Consortium	The Northeast Oklahoma Tribal Transit Consortium, a consortium of nine tribal nations in Northeast Oklahoma, first introduced evening on-demand service in 2018. To capitalize on the program's success, the Consortium is seeking capital and operating funding to upgrade its fleet, purchase technology for its phone app and on-demand service, and expand service to daytime hours.
OR	Confederated Tribes of the Umatilla Indian Reservation	The Confederated Tribes of the Umatilla Indian Reservation will receive funding to conduct a feasibility study to expand its transit center to accommodate a growing bus fleet and staff. This project will help improve access to and within the community so that residents can better access jobs, education, and healthcare.

SD	Flandreau Santee Sioux Tribe	The Flandreau Santee Sioux Tribe will receive funding to conduct a feasibility study to establish and operate a transit authority to serve transit-dependent residents in Moody, Brookings, and Minnehaha Counties near the Flandreau Santee Sioux reservation. This project will improve access to and within the community and connect tribal residents to jobs, healthcare, and other opportunities.
VA	Upper Mattaponi Indian Tribe	The Upper Mattaponi Indian Tribe will receive funding to initiate transit service for residents of the reservation and near the Tribe's reservation in King and Queen's Counties. The Tribe will buy electric, wheelchair-accessible vans, charging equipment, a maintenance facility, and communications systems to support operations and maintenance.
WA	The Spokane Reservation	The Spokane Reservation will receive funding to purchase paratransit vehicles and hire additional drivers to provide the Moccasin Express transportation service on the reservation, which primarily serves tribal members.
WI	Bad River Band of Lake Superior Tribe of Chippewa Indians	The Bad River Band of Lake Superior Tribe of Chippewa Indians will receive funding for outreach and education to inform Bad River's Transit Strategic Plan. The funding will be used for service decisions and a potential expansion of service to better meet transit needs in the Bad River community.
WI	Menominee Indian Tribe of Wisconsin	The Menominee Indian Tribe of Wisconsin will receive funding to replace transit vehicles that have reached the end of their useful life. The new vehicles will help improve connections between the Menominee Reservation and surrounding counties in Wisconsin.
WI	Forest County Potawatomi Community	The Forest County Potawatomi Community will receive funding to buy a zero-emission passenger vehicle or electric van to serve a new route connecting the Community Center to nearby schools, supporting school programming and opportunities.
