Ecosystem Restoration and Resilience Framework and Projects

The Bipartisan Infrastructure Law is a major investment in the conservation and stewardship of America’s public lands that will lead to better outdoor spaces and habitats for people and wildlife for generations to come. In recognition that healthy ecosystems are part of the Nation’s infrastructure, the law provides nearly \$1 billion through the Ecosystem Restoration Section (40804) for locally led, collaborative projects that build resilience to climate change, restore healthy lands and waters, and enhance communities’ quality of life.

The Department developed the [Restoration and Resilience Framework](#) to support coordination across agency programs to plan, implement, and monitor the projects.

The Department and other Federal agencies have also partnered with the National Fish and Wildlife Foundation and private sector to support and enable Americans to think big about large-scale, locally led restoration projects spanning public, Tribal, and private lands through the [America the Beautiful Challenge](#) grant program. This nearly \$400 million investment from the Bipartisan Infrastructure Law complements financial contributions from other Federal agencies and private philanthropic funding streams to advance conservation and restoration projects throughout the nation.
