Home Energy Rebates Update

DOE Sets Deadline for States and Territories to Apply for Early Administrative Funding

The U.S. Department of Energy (DOE) has set a deadline of May 31, 2024, for state and territorial energy offices (SEOs) to apply for Home Energy Rebates early administrative funding.

SEOs can use this funding to begin planning their programs. When applying, SEOs are eligible to receive up to 2.5 percent of their total allocations from each Rebates program, capped at \$2.5 million per rebate program, or \$5 million total. SEOs may bypass this application and receive these funds as part of their full program funding.

DOE is instituting this May 31 deadline to focus its resources on reviewing full funding applications and helping states launch programs. DOE encourages SEOs that haven't begun an early administrative funding application to focus instead on submitting their full funding application **as soon as possible**.

The deadline for SEOs to submit full funding applications to DOE is January 31, 2025. DOE has provided numerous [technical assistance resources](#) to help SEOs apply, including sample application responses for the [Home Efficiency Rebates](#) and [Home Electrification and Appliance Rebates](#) programs. These resources significantly reduce the burden of completing the application and helped our [first four applicants](#) complete their applications in a matter of weeks.

To date, DOE has awarded \$74.2 million in early funding to 25 states and territories. [Our tracker shows which states and territories have applied](#).

About Home Energy Rebates

On Aug. 16, 2022, President Joseph R. Biden signed the landmark Inflation Reduction Act. The law includes nearly \$400 billion to support clean energy and address climate change, including \$8.8 billion in [Home Energy Rebates](#), which will provide two separate rebates to consumers:

The [Home Efficiency Rebates](#) will provide \$4.3 billion to discount the price of energy-saving retrofits in single-family and multi-family buildings. These rebates will be administered by states and territories.

The [Home Electrification and Appliance Rebates](#) will provide \$4.5 billion in rebates for high-efficiency electricity upgrades in homes. These rebates will be administered by states, territories, and Indian tribes.
