## **Information for Capacity Builders**

# For Those Interested in Providing Technical Assistance through the Thriving Communities Program -Application Opportunity is Now Closed

The U.S. Department of Transportation (DOT) accepted applications from eligible applicants interested in providing technical assistance, planning, and capacity building support to disadvantaged communities to help them build the technical tools and organizational capacity to compete for federal aid and deliver quality infrastructure projects that enable their communities and neighborhoods to thrive until November 28, 2023.

This year's Thriving Communities Program offers two separate opportunities, solicited under a single Notice of Funding Opportunity:

# Thriving Communities National Capacity Builder Program (TCP-N)

The Thriving Communities National Program (TCP-N) will fund organizations to provide technical assistance, planning, and capacity building support to communities located across the U.S. and selected by DOT through a separate but parallel Letter of Interest process. Eligible applicants to the TCP-N program include:

# Thriving Communities Regional Capacity Builder Pilot Program (TCP-R)

For the FY 2023 program, DOT is excited to announce the new Thriving Communities Regional Pilot Program (TCP-R). The program funds state, regional, Tribal, and local governments and organizations to provide technical assistance, planning, and capacity building support to communities for transportation plans and projects located within their geographic/service area. The program emphasizes support for plans or projects that align with housing, economic development, public health, climate, and other community development goals. Unlike the TCP-N

program, TCP-R applicants will select communities from their own geographic service area; DOT will not select these communities.

- Eligible applicants to the TCP-R program include:
- State governments and their agencies
- Indian Tribes
- Local governments and their agencies
- Governmental planning, economic development, or transportation organizations working at the regional or metropolitan level
- Regional, Tribal, or statewide planning non-profits

## FY 2023 Notice of Funding Opportunity

The <u>FY23 Notice of Funding Opportunity (NOFO)</u> is now closed. **The application period closed on November 28, 2023.** For questions, contact ThrivingCommunities@dot.gov.

## How Will DOT Make Selections?

DOT anticipates awarding at least three separate cooperative agreements (of \$4-5 million each) to TCP-N applicants, as well as at least four cooperative agreements (\$1-2 million each) to TCP-R applicants. DOT will prioritize applicants who demonstrate the ability to develop and provide technical assistance, planning, and capacity building tools to disadvantaged communities.

DOT will review complete and eligible applications and evaluate them based on the applicant's approach to technical assistance and capacity building, teaming arrangements, proven success, and program management and evaluation.
